- (ii) That AMSAG and the Associated Entities do not make any warranty, implied or express, that the event services will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied; and
- (iii) to attend or participate in the event at your own risk.

You acknowledge that:

- (ii) motor vehicles (or parts of them) colliding with other motor vehicles, persons or property;
